How will it be used?

- To contract pharmaceutical businesses to promote our services
- To produce marketing information

Where will the data be stored?

All data collect will be stored within the United States of America. The third-party company is sign up to the Privacy Shield, which is a mechanism to ensure non-EU Companies comply with Data Protection requirements when transferring personal data from Europe.

Automated decisions

No automated decision making is used with the data collected.

Your rights as a data subject

As a data subject, you have a number of rights. You can:

- Access and obtain a copy of your data on request;
- Require the organisation to change incorrect or incomplete data;
- Require the organisation to delete or stop processing your data, for example where the data is no longer necessary for the purposes of processing; and
- Object to the processing of your data where Spirit is relying on its legitimate interests as the legal ground for processing.
